2 AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA,  
3 AMENDING CHAPTER 19.623 OF THE RIVERSIDE MUNICIPAL CODE  
4 REGARDING BILLBOARD SIGNS AND AMENDING TABLE 19.650.020  
5 REGARDING APPROVING AND APPEAL AUTHORITY.

6 The City Council of the City of Riverside, California, does ordain as follows:

7 Section 1: Section 19.623.025 of the Riverside Municipal Code entitled “Relocation of  
8 existing billboards; billboard relocation agreements” is added as shown in Exhibit “A” attached hereto  
9 and incorporated herein.

10 Section 2: The title of Section 19.623.030 of the Riverside Municipal Code is amended as  
11 follows:  
12 “Section 19.623.030 Relocation of existing billboards (On Parcel Annexed into the City of  
13 Riverside).”

14 Section 3: Section 19.623.040 of the Riverside Municipal Code is amended as follows:  
15 “19.623.050 Severance.”

16 Section 4: Section 19.623.040 of the Riverside Municipal Code entitled “Billboard relocation  
17 permit” is added as shown in Exhibit “B” attached hereto and incorporated herein.

18 Section 5: Table 19.650.020 of the Riverside Municipal Code entitled “Approving and Appeal  
19 Authority” is amended as shown in Exhibit “C” attached hereto and incorporated herein.

20 Section 6: The City Council has reviewed the matter and, based upon the facts and information  
21 contained in the staff reports, administrative record, and written and oral testimony,  
22 hereby finds that this ordinance is not subject to CEQA pursuant to Section 15061(b)(3) (General  
23 Rule), as it can be seen with certainty that approval of the project will not have an effect on the  
24 environment.

25 Section 7: The City Clerk shall certify to the adoption of this Ordinance and cause publication  
26 once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City  
27 of Riverside. This Ordinance shall become effective on the 30th day after the date of its adoption.
