

GENERAL FUND EXPENDITURES



MEASURE Z REVENUE & EXPENDITURES



Electric Fund



Water Fund



Refuse Fund



Sewer Fund



RECOMMENDATIONS

That the City Council:

1. Receive and provide input on the Fiscal Year 2024/25 Third Quarter Financial Update;
2. With at least five affirmative votes, authorize a supplemental appropriation and interfund transfer from the Regional Park Special Capital Improvement to the General Fund in the amount of \$500,000; and
3. Approve a budget reduction of \$2,000 in the General Fund, City Council Ward 6, Office Supplies and Travel budget as a General Fund cost savings measure.
