9	obtain their consent and support for the renaming; and
10	WHEREAS, as the proposed street renaming is a City-initiated project, it is not subject to the
11	process requirements of Title 19 of the Riverside Municipal Code; however, in an effort to solicit
12	comments and give prior notice, door-to-door canvassing and engagement of residents of Price Court
13 14	was completed; and
14	WHEREAS, as this is a ceremonial street name change only, none of the residents would need
16	to make any change to their postal address or any official documents.
17	NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
18	California, as follows:
19	Section 1: That Price Court, as shown on the map in the attached Exhibit "A," and
20	incorporated herein by reference, is hereby ceremonially changed to Winek Court.
21	Section 2: That a single ceremonial sign, as shown in the attached Exhibit "B," and
22	incorporated herein by reference, is posted at the spot designated on the map in Exhibit "A."
