A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
CALIFORNIA APPROVING THE CEREMONIAL STREET NAME  
CHANGE FOR PRICE COURT

WHEREAS, Councilmember Jim Perry has presented the proposal for a ceremonial street name change for Price Court; and

WHEREAS, the renaming would honor the Winek Family who tragically lost their lives on November 25, 2022; and

WHEREAS, discussions were initiated with the immediate neighbors and surviving family to obtain their consent and support for the renaming; and

WHEREAS, as the proposed street renaming is a City-initiated project, it is not subject to the process requirements of Title 19 of the Riverside Municipal Code; however, in an effort to solicit comments and give prior notice, door-to-door canvassing and engagement of residents of Price Court was completed; and

WHEREAS, as this is a ceremonial street name change only, none of the residents would need to make any change to their postal address or any official documents.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: That Price Court, as shown on the map in the attached Exhibit "A," and incorporated herein by reference, is hereby ceremonially changed to Winek Court.

Section 2: That a single ceremonial sign, as shown in the attached Exhibit "B," and incorporated herein by reference, is posted at the spot designated on the map in Exhibit "A."
