

**FIRST AMENDMENT TO
PROFESSIONAL CONSULTANT SERVICES AGREEMENT**

Riverside Regional Water Quality Control Plant Inorganic and Organic Chemical Analyses

This FIRST AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT (“First Amendment”) is made and entered into this ____ day of _____, _____, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), and BABCOCK LABORATORIES, INC., a California corporation (“Consultant”), with reference to the following facts:

RECITALS

WHEREAS, on June 26, 2023, City and Consultant entered into that certain Professional Consultant Services Agreement (“Agreement”) for Riverside Regional Water Quality Control Plant Inorganic and Organic Chemical Analyses, with compensation in the amount not to exceed One Hundred Sixty-Seven Thousand Four Hundred Seventy Dollars (\$167,470.00); and

WHEREAS, the Agreement is set to expire on June 30, 2026; and

WHEREAS, City and Consultant desire to extend the term of the Agreement for two (2) additional years, through June 30, 2028; and

WHEREAS, City and Consultant desire to increase compensation in the amount of One Hundred Thirty-Seven Thousand Nine Hundred Eighty-Six Dollars (\$137,986.00) for the extended term of the Agreement, for a total revised contract amount not to exceed Three Hundred Five Thousand Four Hundred Fifty-Six Dollars (\$305,456.00).

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Consultant mutually agree as follows:

1. Section 2, “Term,” is hereby amended to extend the term of the Agreement for two (2) additional years, through June 30, 2028.

2. Section 3, “Compensation/Payment,” is hereby amended to increase compensation in the amount of One Hundred Thirty-Seven Thousand Nine Hundred Eighty-Six Dollars (\$137,986.00) for the extended term of the Agreement, for a total revised contract amount not to exceed Three Hundred Five Thousand Four Hundred Fifty-Six Dollars (\$305,456.00).

3. All terms and conditions of the Agreement not inconsistent herewith shall remain in full force and effect and are hereby incorporated by reference into this First Amendment as though set forth in full herein.
