The City Council (1) approved the Professional Services Agreement to Coffman Associates, Inc., a Missouri corporation, in the amount of \$849,157 for the Airport Economic Impact Study/Development Plan and Master Plan for the Riverside Airport, located at 6951 Flight as requested in Request for Proposal 2423; (2) authorized 15 percent change order authority in an amount up to \$127,373.55 for project changes including, but not limited to, unforeseen conditions, or necessary design changes; (3) authorized the Chief Financial Officer, or designee, to record all necessary interfund transfers and supplemental appropriations in the amount of \$976,530.55 from the General Fund Infrastructure Reserve to the Airport Fund, Airport Master Plan Project revenue and expenditure accounts; and (4) authorized the City Manager, or his designee, to execute a Professional Consultant Services Agreement with Coffman Associates, Inc., including making minor and non-substantive changes.

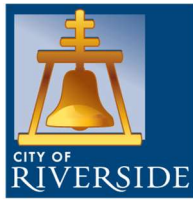

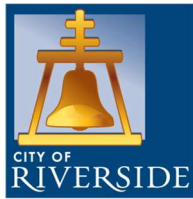

Duran Eastside Library Project at 2060 University to Horizons Construction Company, Orange, including demolition, hazardous abatement, and new construction, in the amount of \$16,128,715; (2) approved 10 percent construction contingency in the amount of \$1,612,872, for unforeseen conditions or design changes; (3) authorized the City Manager, or designee, to execute the Construction Services Agreement, including making minor and non-substantive changes; (4) authorized the Chief Financial Officer, or designee, to record an interdepartmental and interfund transfer and a supplemental appropriation in the amount of \$350,894 from the General Fund, Library Land and Building Rental Account to the Capital Outlay Fund, General Services Eastside Library Project Account; (5) authorized the Chief Financial Officer, or designee, to record a supplemental appropriation and interfund transfer in the amount of \$1,000,000 from the General Fund Infrastructure Reserves into the Capital Outlay Fund, Eastside Library Project Account; and (6) authorized the Chief Financial Officer, or designee, to record a supplemental appropriation in the amount of \$128,211 in the Grants and Restricted Programs Fund, Eastside Library Project Account offset by funds transferred from the Interest-Bearing Special Deposit Fund Library-Daniels/Miller et al Trust Account to the Grants and Restricted Programs Fund.
