Library Director, Erin Christmas, provided an update on the SPC Jesus S. Duran Eastside Library. She shared that on August 5, the City Council awarded the bid to build the new SPC Jesus S. Duran Eastside library to Horizons Construction Company and all funding for the project has been secured.

Erin also announced that there will be a groundbreaking ceremony on Saturday September 6 at 10am at Bobby Bonds Park to celebrate the new facility.

Item 11 SPC Jesus S. Duran Eastside Library Services at Lincoln Park Community Center and Mobile Library Park Visits

Assistant Library Director, Jessica Herdina, presented on the success of the SPC Jesus S. Duran Eastside Library at Lincoln Park Community Center and the mobile library park visits. She shared statistics related to service hours, visitors, library cards issued, books checked-out, storytime participants and lunches served.
