

FIRST AMENDMENT TO SERVICES AGREEMENT

FLO SERVICES, INC.

On-Call Repair, Maintenance, and Services for Various Sewer Lift Station Pumps

This FIRST AMENDMENT TO SERVICES AGREEMENT (“First Amendment”) is made and entered into this ____ day of _____, 2024, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), and FLO SERVICES, INC., a California corporation (“Contractor”).

RECITALS

WHEREAS, on June 7, 2023, City and Contractor entered into a Services Agreement for On-Call Repair, Maintenance, and Services for Various Sewer Lift Station Pumps (“Agreement”); and

WHEREAS, the Agreement was for a two (2)-year term, beginning June 7, 2023; and

WHEREAS, City and Contractor desire to extend the Agreement through June 30, 2025, and increase Compensation in the amount of Two Hundred Seventy-Five Thousand Dollars (\$275,000.00), for the extended term of the Agreement, for total Compensation in the amount of Four Hundred Twenty-Five Thousand Dollars (\$425,000.00).

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Contractor agree as follows:

1. The term of the Agreement is hereby extended through June 30, 2025.
2. Paragraph 3, Compensation, is hereby amended to increase Compensation in the amount of Two Hundred Seventy-Five Thousand Dollars (\$275,000.00), for the extended term of the Agreement, for total Compensation in the amount of Four Hundred Twenty-Five Thousand Dollars (\$425,000.00).
3. All terms and conditions of the original Agreement not inconsistent with this First Amendment shall remain in full force and effect and are incorporated herein by this reference as though set forth in full.


