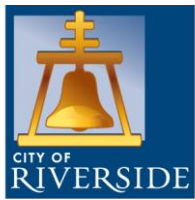
The minutes of the meeting on January 24, 2024, were approved as presented.

ELECTION OF CHAIR AND VICE CHAIR OFFICERS NOMINATIONS INFORMATION

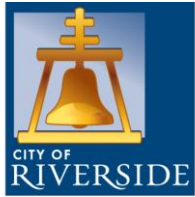
