

**THIRD AMENDMENT TO

THIS THIRD AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("Third Amendment") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2025, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and LEGAL ACCESS PLANS, INC., a California corporation, doing business as LEGALEASE ("Consultant"), with respect to the following:

**RECITALS**

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated January 1, 2019 ("Agreement"), for Group Legal Insurance for Employees (RFP No. 1822) ("Project"); and

WHEREAS, the City and Consultant entered into that certain First Amendment to Professional Consultant Services Agreement dated June 30, 2020 ("First Amendment"), to extend the Term of the Agreement; and

WHEREAS, the City and Consultant entered into that certain Second Amendment to Professional Consultant Services Agreement dated November 1, 2022 ("Second Amendment"), to extend the Term of the Agreement; and

WHEREAS, the Agreement is set to expire June 30, 2025; and

WHEREAS, the City and Consultant desire to amend the Agreement to extend the Term for an additional five (5) months, through November 30, 2025.

NOW, THEREFORE, incorporating the recitals, which are incorporated herein by this reference, City and Consultant agree as follows:

1. The Term of the Agreement is hereby extended for an additional five (5) months, through November 30, 2025.

2. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Third Amendment, shall remain in full force and effect as if fully set forth herein.




