BACKGROUND

1. September 2016 – SB 1383
 - 20% edible food recovery by 2025
 - 75% reduction in organic waste disposal by 2025 (vs. 2014)
2. August 2020 – City Council
 - Public Works Renewable Resources Management Plan
 - Regulatory needs, efficiencies, climate, sustainability
3. January 2023 – RFP 2222
 - Public-private partnership (P3) digestate and biogas project

BACKGROUND

1. Anaerobic digestion is decomposition of biodegradable materials under low oxygen conditions
2. Common treatment practice for solid wastes including food waste
3. Produces two main products: digestate and biogas

2. Optimize infrastructure, generate revenue from biogas & digestate, support SB 1383 compliance via waste recycling
3. P3 entity provides financing, infrastructure, and operations, which reduces project risk to City

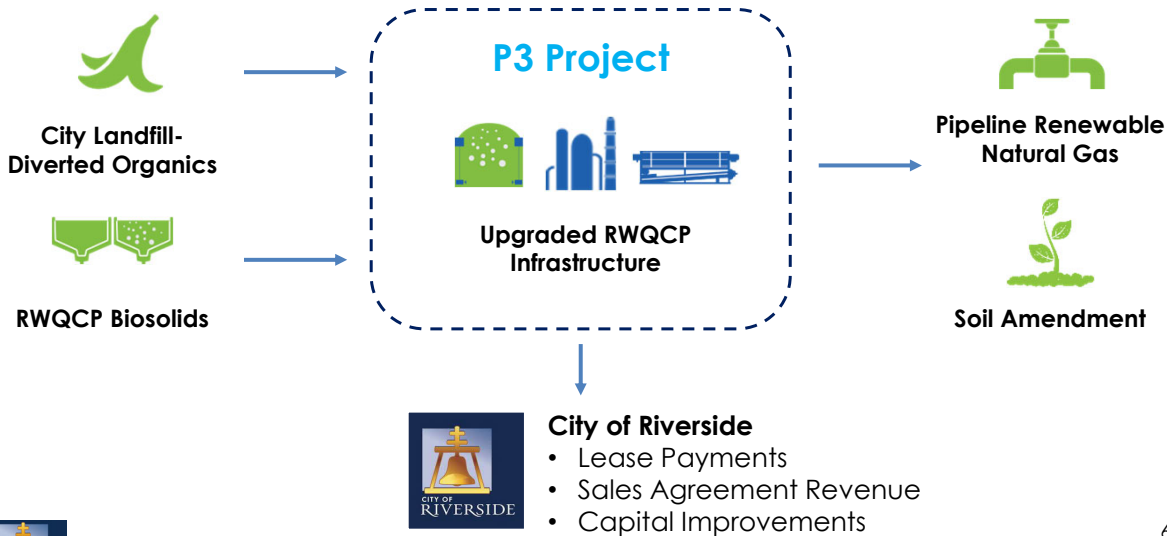

4. P3 negotiations authorized on February 24, 2023
5. Application deadline April 20, 2023
