THIS THIRD AM	ENDMENT TO SERVICE	AGREEMENT ("Third Amendment") is
made and entered into this	day of	, 2024, by and between
the CITY OF RIVERSID	E, a California charter city	and municipal corporation ("City"), and
RPW SERVICES, INC., a	California corporation ("Cor	ntractor"), with respect to the following:

## **RECITALS**

WHEREAS, on or about July 1, 2020, City and Contractor entered into a Services Agreement for Annual Maintenance of Fairmount Park; and

WHEREAS, on or about April 28, 2022, the City and Contractor entered into a First Amendment to Services Agreement to extend the term of the Agreement for an additional one year and provide for compensation during that extended term in the amount of Forty-One Thousand Nine Hundred Fifty-Six Dollars (\$41,956.00), plus an additional 25% charge order authority; and

WHEREAS, on or about August 23, 2023, the City and Contractor entered into a Second Amendment to Services Agreement to extend the term of the Agreement for an additional one year, with additional increased compensation during the extended term for Forty-One Thousand Nine Hundred Fifty-Six Dollars (\$41,956.00); and

WHEREAS, the Agreement included an option to extend the term of the Agreement for three (3) additional one-year terms, upon mutual written agreement of the parties; and

WHEREAS, the City and Contractor desire to exercise that option to extend the Agreement for an additional one (1) year, until June 30, 2025, with compensation for this additional time period to be Fifty-Eight Thousand Dollars (\$58,000.00).

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, the City and Contractor agree as follows:

- 1. Section 2, "Term", is hereby amended to extend the term of the Agreement to June 30, 2025.
- 2. Section 3, "Compensation", is hereby amended to increase compensation for the extended term to Fifty-Eight Thousand Dollars (\$58,000.00).

3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Third Amendment, shall remain in full force and effect as if fully set forth herein.
