Item 6 Receive Recurring Update on the New SPC Jesus S. Duran Eastside Library

Erin Christmas, Library Director, provided an update on the new SPC Jesus S. Duran Eastside Library. Groundbreaking is anticipated early 2nd quarter next year. A community meeting will be held in January/February for feedback on the makerspace area.

Item 7 Informational Report Cooling and Warming Centers at the Library

Jessica Herdina, Assistant Library Director, provided an informational report on cooling and warming centers at the Library. In collaboration with Community Action Partnership (CAP) of Riverside County and in support of CAP's Energy Crisis Response Plan in Riverside County, the City of Riverside entered into an

annual Memorandum of Understanding with CAP to have all eight Riverside Public Library locations serve as cool/warm centers where individuals can seek temporary relief from extreme temperatures. The libraries activate as cool centers from June 1 to October 15 and warm centers from December 1 to March 31 each year. In October 2024 the SSgt. Salvador J. Lara Casa Blanca Library became the first known pet-friendly government cooling center in Riverside County. The library provided access to the outdoor garden as well as a designated area indoors with access to water and emergency supplies, including disposable water dishes, gloves, disposable bags, hand sanitizer, and disinfectant wipes, as available. The pet-friendly cooling center opened just in time for the October heatwave and was able to provide relief to four people and their animal companions.

Erin Christmas, Library Director, informed the Trustees of their previous approval on August 12, 2024, in the amount of \$94,000 with OCLC for CloudLibrary services. The Library would like to receive approval to increase the amount of the purchase by \$5,500 for a total Purchase Order amount of \$99,500. If

approved, this will close the gap for services to customers while Overdrive Libby is being launched on December 10.

Trustees recommended to approve the increase to Purchase Order 251054 with OCLC Inc., by \$5,500 for a total Purchase Order amount of \$99,500.
