

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, CALLING, PROVIDING FOR AND GIVING NOTICE OF A
4 GENERAL MUNICIPAL ELECTION TO BE HELD JUNE 2, 2026 IN THE
5 CITY OF RIVERSIDE, FOR THE PURPOSE OF ELECTING A MEMBER OF
6 THE CITY COUNCIL FROM THE SECOND, FOURTH AND SIXTH
7 WARDS OF SAID CITY OF RIVERSIDE; AND REQUESTING THE
8 COUNTY OF RIVERSIDE TO CONSOLIDATE THE CONTEST FOR CITY
9 COUNCIL WITH THE STATEWIDE PRIMARY ELECTION AND ALL
10 OTHER ELECTIONS BEING HELD IN THE SAME TERRITORY ON THE
11 SAME DATE.

12 The City Council of the City of Riverside does hereby resolve as follows:

13 **Section 1:** That in accordance with the provisions of the Charter of the City of Riverside
14 and the Constitution and election laws of the State of California, a General Municipal Election be
15 held and the same is hereby called and ordered to be held in the City of Riverside on June 2, 2026
16 for the purpose of electing three (3) members of the City Council of the City of Riverside. The
17 members of the City Council shall be from the even-numbered wards of the City of Riverside as
18 established by the City Council.

19 **Section 2:** That in accordance with Section 10002 of the Elections Code, the Riverside
20 County Board of Supervisors are hereby requested to consent to the Riverside County Registrar of
21 Voters rendering election services to the City of Riverside as may be requested by the City Clerk
22 of said City, and that the County of Riverside be reimbursed in full for such services as are
23 performed.

24 **Section 3:** That the purpose of holding said General Municipal Election there shall be and
25 hereby are established consolidated voting precincts consisting of a consolidation of the regular
26 precincts in the City of Riverside established for the holding of state and county elections as said
27 regular election precincts exist on the date of this resolution.

28 **Section 4:** That the form and contents of the ballots to be used at said election shall be as
provided by law.

Section 5: That the voting centers for the election shall be open at such hours and on such
days as determined by the Riverside County Registrar of Voters provided that the opening and

1 closure of voting sites is conducted in accordance with Sections 10242, 14212, and 14401 of the
2 Elections Code of the State of California.

3 **Section 6:** Voted ballots must be returned to the Registrar of Voters Office or to one of the
4 drop-off locations, at least one of which shall be located in each ward of the City of Riverside.
5 Voted ballots must be returned no later than 8:00 p.m. on Tuesday June 2, 2026, or be postmarked
6 on or before election day and received no later than seven (7) days after the election day to be
7 counted.

8 **Section 7:** That the City Clerk shall have charge of all City elections pursuant to Riverside
9 City Charter section 703(f).

10 **Section 8:** That the City Clerk is hereby designated the "Elections Official" for the
11 purposes of this election pursuant to Elections Code section 320(b).

12 **Section 9:** That based upon the foregoing authority, the City Clerk shall have charge of
13 this election and shall make all determinations necessary to conduct this election.

14 **Section 10:** That the City Clerk is authorized, instructed and directed to coordinate with
15 the County of Riverside Registrar-Recorder/County Clerk to procure and furnish any and all
16 official ballots, notices, printed matter and all supplies, equipment and paraphernalia that may be
17 necessary in order to properly and lawfully conduct the election.

18 **Section 11:** That the City Clerk of said City shall receive the canvass of the General
19 Municipal Election and shall certify the results to the City Council, as required by law.
