
RENEWABLE ENERGY PROCUREMENT MANDATES AND RECENT ACTIVITIES STATUS UPDATE Following discussion and without formal motion, the Committee received and ordered filed the report on the Public Utilities Electric Department's renewable energy procurement mandates and recent activities.

AXLE RESTRICTION PROHIBITING CUT-THROUGH TRAFFIC BY COMMERCIAL VEHICLES EXCEEDING THREE AXLES ON TRAUTWEIN ROAD BETWEEN ALESSANDRO BOULEVARD AND VAN BUREN BOULEVARD

Following discussion, it was moved by Chair Conder and seconded by Member Perry to recommend that City Council approve an axle restriction prohibiting cut-through traffic by commercial vehicles exceeding three axles on Trautwein Road between Alessandro Boulevard and Van Buren Boulevard. The motion carried unanimously.

Public Works Deputy Director Nathan Mustafa provided updates including (1) State Plan Amendment 21 (SPA 21) grant through the Riverside County Transportation Commission (RCTC) to construct citywide pedestrian crossings and bicycle facilities improvements; (2) sidewalk improvements on Stover Avenue; (3) receipt of \$16.5 million in active transportation program funds including the (a) Five Points pedestrian improvements in the La Sierra neighborhood; (b) Riverside Civil Rights Walk in Downtown; and (c) Mitchell Avenue side path and gap closure; and (3) Parking Services infrastructure improvements at parking facilities.
