ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING THE ZONING MAP OF THE CITY OF RIVERSIDE PURSUANT TO CHAPTER 19.090 OF THE RIVERSIDE MUNICIPAL CODE BY REZONING APPROXIMATELY 14.42 ACRES OF PROPERTY LOCATED AT 2626 KANSAS AVENUE, 2069 MASSACHUSETTS AVENUE, AND 1989 MASSACHUSETTS AVENUE, FROM THE I-ID – GENERAL INDUSTRIAL AND INNOVATION DISTRICT (EE – EMPLOYMENT EMPHASIS AND HE - HOUSING EMPHASIS SUBDISTRICT) OVERLAY ZONE TO I-ID – GENERAL INDUSTRIAL AND INNOVATION DISTRICT (IE – INDUSTRIAL EMPHASIS SUBDISTRICT) OVERLAY ZONE.

The City Council of the City of Riverside, California, does ordain as follows:

Section 1: Pursuant to Chapter 19.090 of the Riverside Municipal Code, the Zoning Map of the City of Riverside is hereby amended by removing from the I-ID – General Industrial and Innovation District (EE – Employment Emphasis and HE - Housing Emphasis Subdistrict) Overlay Zone to I-ID – General Industrial and Innovation District (IE – Industrial Emphasis Subdistrict) Overlay Zone, the approximately 14.42 acres of property located at 2626 Kansas Avenue, 2069 Massachusetts Avenue, and 1989 Massachusetts Avenue, situated on the north side of Massachusetts Avenue, east of Kansas Avenue and south of Roberta Street, identified as Assessor’s Parcel Numbers 210-130-015, 210-130-016, and 210-130-020, as described and depicted in Exhibit “A” attached hereto and incorporated herein by reference, subject to all of the conditions, restrictions and covenants imposed under Planning Case No. PR-2024-001666, which conditions, restrictions and covenants are incorporated herein by reference.

Section 2: The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
