RECITALS

WHEREAS, on January 13, 2023, City and Staples & Associates, Inc., entered into that certain Professional Consultant Services Agreement, in conjunction with Consultant Administered Refrigerated Load Program – RFP No. 2138 ("Agreement"), in the amount of Two Hundred Fifty Thousand Dollars (\$250,000.00); and

WHEREAS, the City and Consultant desire to amend the Agreement to increase compensation not to exceed Seven Hundred Fifty Thousand Dollars (\$750,000.00) with the option to extend for two (2) additional years in an amount of Two Hundred Fifty Thousand Dollars (\$250,000.00); and

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Consultant agree as follows:

- 1. Section 3, <u>Compensation/Payment</u>, is amended to increase to the compensation to the total sum not to exceed Seven Hundred Fifty Thousand Dollars (\$750,000.00). Compensation during the optional extensions shall be in an amount of Two Hundred Fifty Thousand Dollars (\$250,000.00) per year.
- 2. All other terms and conditions of the Agreement between the parties which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.
