### DISCUSSION CALENDAR

#### **CITYWIDE SPEED LIMIT REDUCTION PROGRAM**

An Engineering & Traffic Survey (E&TS) evaluated 319 roadway segments for potential speed limit reductions. It recommended lowering limits on 135 segments by 5-10 MPH, with no increases suggested. Research shows a significant relationship between vehicle

speed and pedestrian survival rates in collisions. Sixty-three segments were identified as Safety Corridors, eligible for an additional 5 MPH speed limit reduction due to high crash rates. The Policy Recommendations and Implementation Plan prioritize speed management in areas with excessive speeding and vulnerable users, suggesting cost-effective measures like speed limit markings and feedback signs. The final recommendations resulted in 150 unchanged segments, 135 reduced, and 34 with new limits. Public Works will coordinate with the Police Department for enforcement once the new limits are adopted.

In conclusion, we also received one e-comment in support and a request to change the speed limit to 35 mph for a portion of Victoria Avenue.

Following discussion, it was moved by Board Member C. Collins, seconded by J. Trinh, to approve the staff's recommendation and to amend the requested portion on Victoria Avenue and change it to 35 mph. The motion passes unanimously with Chair J. Bulinski, Board Members C. Cullen, J. Trinh, K. Brown, and C. Collins, voting yes.

### **LARKIN COURT – ESTABLISHMENT OF A TIMED 2-HOUR PREFERENTIAL PARKING ZONE**

The Public Works Department received a petition from 75% of Larkin Court residents requesting a "2-Hour Parking from 8:00 p.m. to 6:00 a.m., except for residents with permits" Preferential Parking Zone (PPZ). Residents cite issues with outside parking from Lorraine Terrace Apartments, such as limited availability, driveway blockages, noise, and litter. A second recommendation included a proposed one-way northbound only pilot project along Monroe Street (frontage road) between Ouida Drive and Monroe Street (arterial road) to increase on-street parking capacity.

If approved, the PPZ would help ensure adequate parking for residents during peak hours while allowing unrestricted parking outside of these times.

In conclusion, five individuals spoke in support and two in opposition to the city staff's recommendation; one call was received in support, and no e-comments or emails were received.

### **REQUEST FOR SPEED HUMPS ON LURIN AVE.**

Residents of Lurin Avenue petitioned for speed humps, with 73% in favor, meeting the city's requirement. Staff confirmed the street met all technical criteria for installation. Traffic surveys showed speeds exceeding the 25 MPH prima facie speed limit, prompting the suggestion of Type II Speed humps for emergency access. Five possible locations for the speed humps have been identified, aiming to reduce speeding while considering emergency vehicle response times.

In conclusion, two individuals spoke in support of the city staff's recommendation; one call was received in support, and four e-comments in support, no emails were received.

Following discussion, it was moved by Board Member C. Collins, seconded by C. Cullen, to approve the staff's recommendation. The motion passes unanimously with Chair J. Bulinski, Board Members C. Cullen, J. Trinh, K. Brown, and C. Collins, voting yes.

### **2026 TRANSPORTATION BOARD WORK PLAN**
