SUBJECT: HEARING ON THE CODE OF ETHICS AND CONDUCT COMPLAINT

SUBMITTED BY DANA CISNEROS, ESQ. ON BEHALF OF PACKS RIVERSIDE, LLC, AND OTC RIVERSIDE, LLC REGARDING CITY COUNCILMEMBER MILL

## **ISSUE:**

Conduct a Hearing on the Code of Ethics and Conduct complaint by Dana Cisneros, Esq., on behalf of Packs Riverside, LLC and OTC Riverside, LLC regarding Councilmember Mill submitted on August 11, 2025, and deemed complete and filed on August 18, 2025.

### **RECOMMENDATION:**

That the Board of Ethics conduct a Hearing as required by Riverside Municipal Code (RMC) Section 2.78.080 for the Code of Ethics and Conduct complaint by Dana Cisneros Esq. on behalf of Packs Riverside, LLC and OTC Riverside, LLC, regarding Councilmember Mill submitted on August 11, 2025, and deemed complete and filed on August 18, 2025.

#### **DISCUSSION:**

On August 11, 2025, Dana Cisneros Esq. submitted a Code of Ethics and Conduct complaint on behalf of TAT RV, LLC, Packs Riverside, LLC and OTC Riverside, LLC, against Councilmember Mill, which was deemed complete and filed on August 18, 2025, alleging violations of (1) RMC Section 2.78.060(I) Knowingly assisting another public official in violating this Code of Ethics and Conduct prohibited; (2) Section 2.78.060(K) Ex Parte Contact in Quasi-Judicial Matters Prohibited; and (3) Section 2.78.060(M) Violations of Local Law Prohibited.

At the September 4, 2025, meeting, the Board found that (1) the complaint procedures were followed; (2) TAT RV, LLC should be removed from the complaint; (3) Section 2.78.060(M) Violations of Local Law Prohibited should be removed from the complaint; and (4) the evidence provided by the complaint did show that it is more likely than not that there may be a potential violation of the Riverside Municipal Code Section 2.78.060(I) and Section 2.78.060(K).

The Hearing Panel set a time limit of 30 minutes for each party to present their case at the hearing.

# **FISCAL IMPACT**:

There is no fiscal impact associated with this report.
