CODE OF ETHICS AND CONDUCT ANNUAL REVIEW

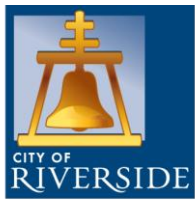
Following discussion and without formal motion, the Budget Engagement Commission received and ordered filed the update.

FISCAL YEAR 2023-2024 THIRD QUARTER FINANCIAL UPDATE

Following discussion, It was moved by Commission Hutchins and second by Commissioner Scott- Coe that the Budget Engagement Commission; (1) Receive and provide input on the Fiscal Year 2023/24 Third Quarter Financial Update; and (a) Recommend that the City Council, with at least five affirmative votes, authorize the Chief Financial Officer, or designee, to; (2) Record \$330,000 in FY 2023/24 supplemental appropriations in the General Fund, Finance Department, to fund the consultant services contract with Harvard/Partners for Public Good; and (3) Record an increase in FY 2023/24 revenues and supplemental appropriations in the amount of \$260,000 in the General Fund, Finance Department, to modify the accounting treatment of the consultant services contract with Hinderliter, de Llamas and Associates (HdL) for the Business Tax Discovery Program and other services. The motion was carried unanimously with Commissioner Weinrich, Thomas and Holley absent.

PAVEMENT MANAGEMENT PROGRAM UPDATE

Following discussion, it was motioned by Commissioner Vandenberg and Second by Vice Chair Benavidez to advise the city council to prioritize Measure Z spending for pavement improvement efforts. The motion was carried unanimously with Commissioner Weinrich, Thomas and Holley absent.
