A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 24228 AND AUTHORIZING SUBMITTAL OF A REGIONAL APPLICATION FOR WHICH THE CITY OF RIVERSIDE IS ELIGIBLE

WHEREAS, Public Resources Code sections 48000 et seq. authorize the Department of Resources Recycling and Recovery (CalRecycle) to administer various grant programs (grants) in furtherance of the State of California’s (State) efforts to reduce, recycle, and reuse solid waste generated in the state thereby preserving landfill capacity and protecting public health and safety and the environment; and

WHEREAS, the CalRecycle Organic Grant Program, Cycle 6 allows regional grant projects; and

WHEREAS, CalRecycle grant application procedures require, among other things, a regional applicant’s governing body to declare by resolution certain authorizations related to the administration of CalRecycle grants; and

WHEREAS, on October 1, 2019, the City of Riverside adopted Resolution No. 23494 authorizing an application to CalRecycle for an Organic Grant Program and Greenhouse Gas Reduction Program; and

WHEREAS, on January 7, 2020, the City of Riverside adopted Resolution No. 23537 amending Resolution No. 23494 and authorizing submittal of a regional application for which the City of Riverside is eligible.

WHEREAS, on March 4, 2025, the City of Riverside adopted Resolution No. 24228 amending Resolution No. 23537 and authorizing submittal of a regional application for which the City of Riverside is eligible.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the CITY OF RIVERSIDE that the City Council authorizes the City of Riverside to submit a CalRecycle Organic Grant Program,

1 Cycle 6 regional application on behalf of itself as Lead Agency and the participating jurisdictions as  
2 shown by the documentation attached. The participating jurisdiction(s) is Burrtec Waste Industries,  
3 Inc., as set forth in Attachment A to this resolution.

4 BE IT FURTHER RESOLVED that the City Manager, or his designee, is hereby authorized  
5 and empowered to execute on behalf of Burrtec Waste Industries, Inc. all grant-related documents,  
6 including, but not limited to, applications, payment requests, agreements, and amendments necessary  
7 to secure grant funds and to implement the approved grant project; and

9 BE IT FURTHER RESOLVED that these authorizations are effective for two (2) years from  
10 the date of adoption of this resolution.
