### 8. Discuss, receive, and file the Strategic Plan status report for the quarter ending March 31, 2024

The quarterly update for the strategic plan was discussed, received, and filed. In addition to the published report, Museum Director Peterson reported that the process to renew the Museum's strategic plan will begin at the three-year mark. The City is embarking on the process for a new General Plan, and the City's current strategic plan, Envision Riverside 2025, will sunset. The Museum will continue to support City goals.

## COMMUNICATIONS

### 9. Director's Update regarding the main museum renovation, historic houses, collections, exhibitions and programs, budget, staffing, advisory teams, volunteer and support opportunities, marketing, and communications.

In addition to the published report, Director Peterson reported that 52 of the 100 programs for 2024 have been completed, and that by the end of fiscal year ending on June 30, 2024, the Museum will have served close to 17,000 people in person. Heritage House closes for the summer on June 30, 2024, and this weekend is the last chance to see the Chinatown exhibition at Heritage House. Exhibition planning for the reopening of the

downtown Museum site is underway. The Museum is exploring revenue-generating options starting with the 100<sup>th</sup> anniversary gala. The Museum plans to conduct interviews for the Curator of History this summer. FY24-26 budget was approved by City Council at the June 25, 2024, City Council meeting. The Museum will participate in the Long Night of Arts and Innovation. Prequalification processes are underway for general contractors for both the main Museum renovation and expansion and the Harada House Interpretive Center projects. A scavenger hunt for hidden animals in the new mural at 4049 Main Street in downtown Riverside was distributed to the Board. Board members were requested to mark their calendars for the opening of the Museum's 100<sup>th</sup> anniversary exhibition, *Dear Riverside*, being held at the Center for Social Justice and Civil Liberties on July 25, 2024, from 5:30 p.m. to 7:30 p.m.

**8. Board Chair/ Vice-Chair update** – Board Vice Chair Richard Cardullo attended the Riverside Museum Associates business meeting. He congratulated Board Member Peggy Barnhart on her election as RMA President. Richard Cardullo is a new RMA Director-at-Large.

**11. Brief reports on conferences, seminars, and meetings attended by Museum of Riverside Board members**

Board Member Negrón attended National Day of Prayer at Culver Center. Board Member Negrón reported that the Human Relations Commission would like Museum Board members to attend a Human Relations Commission meeting so that the Human Relations Commission can learn more about the Museum.

**12. Items for future Museum of Riverside Board consideration as requested by members of the Board. Only items that fall within the powers and duties of the Museum of Riverside as set forth in the City Charter and/or the Riverside Municipal Code will be agendaized for future discussion.**
