## **RECITALS**

- A. WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated January 4, 2024 ("Agreement"), for Urban Design Services and Support to the Planning Division, with total compensation in the amount of Twenty-Five Thousand Dollars (\$25,000.00); and
- B. WHEREAS, the City and Consultant desire to increase compensation in the amount of Two Hundred Twenty-Five Thousand Dollars (\$225,000.00), with a total sum not to exceed Two Hundred Fifty Thousand Dollars (\$250,000.00); and
- C. WHEREAS, the Agreement is currently set to expire December 1, 2024 and the City and Consultant desire to shorten the term to June 30, 2024.
- NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.
- 1. Section 2, Term, is hereby amended to shorten the term of the Agreement to June 30, 2024.
- 2. Section 3, Compensation, is hereby amended to increase compensation by Two Hundred Twenty-Five Thousand Dollars (\$225,000.00), with a total sum not to exceed Two Hundred Fifty Thousand Dollars (\$250,000.00).
- 3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.
