

## PROPOSAL TO RENAME AIRPORT

The Airport continues to explore alternatives to elevate the airport clientele and generate additional revenues.



#### MUNICIPAL AIRPORT

 The "Municipal" designation in the Airport's name, owing to the City's ownership and operation, while once wellrespected, now has a "small airport" connotation. This does not effectively attract new business or indicate the airport is in growth mode and seeking additional based tenants, including business aviation operators and aeronautical businesses.



#### NAME CHANGE

 To generate renewed enthusiasm for the Airport and attract the interest of business aviation operators, as well as promote the Westside development with a second fixed base operator (FBO), it is appropriate to rename the Airport to:
