# City Council Memorandum

**SUBJECT: BOARD AND COMMISSION APPOINTMENTS AND RESIGNATIONS**

**ISSUES:**

Appoint Nicole Rand to the Commission on Disabilities Ward 3 seat, Anna Gaiserrat to the Museum of Riverside Board Ward 4 seat, Jennifer Beltran to the Commission on Disabilities Citywide seat, and file the resignations of Adele Ann Eberwein from the Commission of the Deaf Ward 7 seat, Julian Turner from the Human Relations Commission Ward 3 seat, Jane DuBois from the Commission on Aging Ward 1 seat, and Tracy Barlogio from the Park and Recreation Commission Citywide seat.

**RECOMMENDATIONS:**

That the Mayor and City Council:

1. Appoint Nicole Rand to the Commission on Disabilities Ward 3 seat for a term through March 1, 2029;
2. Appoint Anna Gaiserrat to the Museum of Riverside Board Ward 4 seat for a term through March 1, 2028;
3. Appoint Jennifer Beltran to the Commission on Disabilities Citywide seat for a term beginning March 1, 2026, through March 1, 2030;
4. File the resignation of Adele Ann Eberwein from the Commission of the Deaf Ward 7 seat; and
5. File the resignation of Julian Turner from the Human Relations Commission Ward 3 seat;
6. File the resignation of Jane DuBois from the Commission on Aging Ward 1 seat; and
7. File the resignation of Tracy Barlogio from the Park and Recreation Commission Citywide seat, effective immediately.

## **BACKGROUND:**

Riverside City Charter Section 802 provides that each board and commission have one representative from each Council Ward.

Pursuant to Resolution 24318, Section XIV (A), Councilmember Robillard recommends that the Mayor and City Council appoint Nicole Rand to the Commission on Disabilities Ward 3 seat for a term through March 1, 2029.

Councilmember Conder recommends that the Mayor and City Council appoint Anna Gaisser to the Museum of Riverside Board Ward 4 seat for a term through March 1, 2028.

Mayor Lock-Dawson recommends that the City Council appoint Jennifer Beltran to the Commission on Disabilities Citywide seat for a term beginning March 1, 2026, through March 1, 2030.

On Wednesday, January 7, 2026, the City Clerk's Office received a resignation from Adele Ann Eberwein. Adele Ann Eberwein held Ward 7 seat on the Commission of the Deaf for a term expiring on March 1, 2029.

On Monday, January 12, 2026, the City Clerk's Office received a resignation from Julian Turner. Julian Turner held the Ward 3 seat on the Human Relations Commission for a term expiring March 1, 2026.

On Wednesday, January 14, 2026, the City Clerk's Office received a resignation from Jane DuBois and Tracy Barlogio. Jane DuBois held the Ward 1 seat on the Commission on Aging for a term expiring March 1, 2029. Tracy Barlogio held the Citywide seat on the Park and Recreation Commission for a term expiring March 1, 2028.

## **FISCAL IMPACT:**

Recruitment and appointment costs are included annually in the City Clerk's budget.
