RIVERSIDE ("City"), a California c	harter city and municipal corporation, and the ALVORD
UNIFIED SCHOOL DISTRICT ("Dis	strict"), herein "the Parties," with respect to the following:

RECITALS

WHEREAS, on September 25, 2019, the City and District entered into that certain Memorandum of Understanding for Reimbursement of Crossing Guard Services ("Agreement"); and

WHEREAS, on March 4, 2024, the City and District entered into that certain First Amendment to Memorandum of Understanding for Reimbursement of Crossing Guard Services ("First Amendment") to add twelve (12) additional crossing guard locations, with the District to reimburse one hundred percent (100%) of the costs for the additional locations to the City; and

WHEREAS, on May 9, 2024, the City and District entered into that certain Second Amendment to Memorandum of Understanding for Reimbursement of Crossing Guard Services ("Second Amendment") to add the Summer Session to all the crossing guard locations, with the District to reimburse one hundred percent (100%) of the costs for the additional locations to the City; and

WHEREAS, on July 24, 2024, the City and District entered into that certain Third Amendment to Memorandum of Understanding for Reimbursement of Crossing Guard Services ("Third Amendment") to extend the term of the Agreement to June 30, 2025, and amend Exhibits A and B; and

WHEREAS, the City and District desire to amend the Memorandum of Understanding to extend the term to June 30, 2026, to change reimbursement percentage during the regular school year.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and District agree as follows:

- 1. Section 1, Term, is amended to extend the term of the Agreement to June 30, 2026.
- 2. Exhibit "A-3" is hereby amended and replaced in its entirety with Exhibit "A-4," attached hereto and incorporated herein by this reference.

- 3. Exhibit "B-3" is hereby amended and replaced in its entirety with Exhibit "B-4," attached hereto and incorporated herein by this reference.
- 4. All other terms and conditions of the Memorandum of Understanding between the parties, which are not consistent with the terms of this Third Amendment, shall remain in full force and effect as if fully set forth herein.
