There was no one wishing to address the Committee.

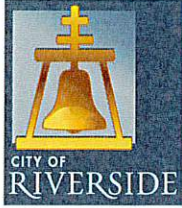
### DISCUSSION CALENDAR

#### ESTABLISHMENT OF AXLE RESTRICTION - SEGMENT OF MADISON STREET BETWEEN INDIANA AND VICTORIA AVENUES

Following discussion, it was moved by Member Perry and seconded by Vice Chair Hemenway recommending that the City Council review and consider the proposed establishment of an axle restriction prohibiting use by commercial vehicles exceeding three axles on the segment of Madison Street between Indiana Avenue and Victoria Avenue for approval. The motion carried unanimously.

### PRESENTATION

Following discussion and without formal motion, the Committee (1) received and ordered filed the report regarding the Riverside County Transportation Commission (RCTC) express lane program including a potential expansion study through State Route 91, Interstate 215, and State Route 60; and (2) expressed support for the study to be conducted by RCTC.

### COMMUNICATIONS

#### PROJECT UPDATES

Public Works Deputy Director Nathan Mustafa provided updates regarding (1) asphalt and concrete repairs throughout the City; (2) Western Riverside Council of Governments' new Nexus Study for Transportation Uniform Mitigation Fee (TUMF) and the adoption of an updated City Council ordinance; (3) the Vehicle Miles Traveled (VMT) Mitigation Bank Program; and (4) pavement Trench Cut fees

Public Works Deputy Director Lee Withers provided updates regarding (1) support for a Western Municipal Water District grant application that was submitted to the U.S. Bureau of Reclamation for a \$1.2 million grant to fund removal of non-functional turf from medians along Trautwein and installation of water efficient landscaping and other future grant opportunities; (2) increasing irrigation system vandalism and associated costs; (3) the positive impacts of Measure Z tree funding.

#### LEGISLATIVE UPDATE

Public Works Deputy Director Nathan Mustafa provided a legislative update regarding (1) Assembly Bill 98 which requires a circulation element to include truck routes in cities with a high concentration of warehouses; and (2) the California State Transit Agency's recent changes to the Climate Action Plan for Transportation Infrastructure (CAPTI) program and the Riverside County Transportation Commission.

### ITEMS FOR FUTURE COMMITTEE CONSIDERATION

There were no items requested by the Committee at this time.
