# **Background & Discussion**

- Measure Z Fire Department vehicle replacement adopted in 2017.
  - o Five (5) year spending plan to replace aging Fire Department Fleet.
  - o 2024 Vehicle Replacement plan was updated.
- Vehicle Replacement Guidelines
  - o National Fire Protection Agency (NFPA) provides Replacement Standards.
  - o Fire Apparatus frontline service ten (10) to fifteen (15) years, depending on maintenance costs.
  - o Fire Apparatus reserve service twenty (20) to twenty-five (25) years, depending on maintenance costs.

  - o 2000 American Lafrance 100' Ladder Company.
  - o Inservice Date: March 29, 2002

- New Fire Apparatus
  - o E-One Cyclone Cab HR-100 Rear Mount Ladder
    - 100' Aerial Ladder
    - 1500 GPM Pump
    - 840 days to build.

#### **Discussion**

- Fire Department Apparatus Committee
  - o Composted of Fire Department Personnel and Fire Fleet Maintenance.
- Selection of E-One Manufacture
  - o Build time: (2) to (3) years. The Current manufacture is (5) to (6) years.
  - o Vehicle Warranty: City Fire Fleet can perform all warranty repairs, but the current vendor does not allow or have a local vendor for repairs.
  - o Ladder: Ladder strength (750) tip loading.
  - Unit Specifications: Unit height, water tank capacity, and reduced compartment space.
