Department Presentation

- Chief Innovation Officer George Khalil presented the Board with a PowerPoint presentation overview of our Innovation and Technology (IT) Department. The presentation included the department's mission, organization, department overview, accomplishments & milestones, department awards & recognition, personnel metrics, and success stories.
- Mr. Khalil informed the Board that his department consists of four (4) divisions (Administration, Innovation, Strategic Initiatives, Cybersecurity) with a total of 63 funded FTEs and 8 vacancies.
- Mr. Khalil shared an overlook of the IT department (9,000+ connected devices managed daily, 30,553 service tickets completed, 37 projects completed, 1.2 million cyberattacks prevented).
- Mr. Khalil shared that 'RIVY' has been launched and averaging 3-500 interactions with the chat box daily.
- Director Khalil informed the Board IT was recognized for 2024 Award of Excellence for IT practices from the Municipal Information Systems Association of California.
- Chair Kerry Pendergast commended the department for their Excellence of Service Award.
- Board Member Antonius Van Vegten inquired about 2025 open enrollment. George stated it's an annual task in our system from (payroll, rates, benefit, bargaining changes).
- Board Member Jadie Lee inquired about 'RIVY', is there a timeline for the integration of the phone being added, and the chat to 311 Call Center. Ms. Khalil stated 'RIVY' is being tested internally as we speak on City work phones, if you dial 'RIVY' on work

phones 'RIVY' will answer. Ms. Lee inquired about personnel metrics and was concerned about your retirement's coming up.

- Vice-Chair Dr. Austin Attaway complimented the IT department on the award received for Excellence of Service and 'RIVY'. George stated we are tying into AI.
- Board Member Joshua Fleming inquired if staff are represented or unrepresented. George stated all staff in IT are unrepresented.
- Board Member Elizabeth Scott-Jones is pleased to hear that IT is working closely with high schools and colleges.
