The motion was carried with Commissioners Tarmo, Dryan-Zagala, and Pellegrino absent.

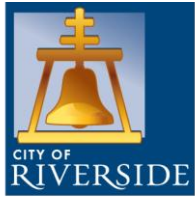
MINUTES
