Chair Friedlander called the meeting to order at 6:30 p.m. and led the pledge of allegiance.

AQUATICS UPDATE

Recreation Supervisor Nicolas Avila delivered an update on the Aquatics Program and introduced Recreation Services Coordinator Steven Perez who also delivered updates on the Aquatics Program.

Commissioner Dawson asked how grants are compared to previous years.

Recreation Services Coordinator Perez stated that if aquatics numbers continuously increase grants will increase and additional funding will be provided.

Commissioner Forbes asked what attributed to the larger pool of lifeguards this year.

Recreation Supervisor Avila stated it was the promotion of all positions, constantly reaching out to agencies, colleges, high schools and past lifeguards pushing the word to youth and younger family members all contributed.

Commissioner Forbes asked what is the adaptive swimming program.

Recreation Services Coordinator Perez stated it is one-on-one swim lessons for special needs or adjustments we need to take into consideration, the instructor will work with the student to

make sure they get the most of their swim lesson.

Chair Friedlander asked if there were special hours for any temperature related changes.

Recreation Services Coordinator Perez stated if the temperature goes over 100 degrees aquatics will get an additional crew, if staff is available and have an emergency opening.

Commissioner Forbes asked if weekends are included for the emergency openings.

Recreation Services Coordinator Perez confirmed weekends are included.
