At this meeting, the City Council will receive public comment on the draft Fiscal Year 2024-2025 HUD Annual Action Plan that will be finalized and submitted to HUD.

The Annual Action Plan is part of the City's grant application to HUD. The Plan implements the housing and community development priorities for the City of Riverside and allocates funding to specific programs and projects that will help benefit low- and moderate-income persons and communities for a given year. The Annual Action Plan will appropriate Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), Emergency Solutions Grant (ESG), and Housing Opportunities for Persons with AIDS (HOPWA) funding to specific programs and projects for the 2024-2025 fiscal year.
