ATTENDANCE

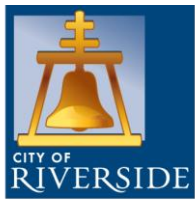
Commission of the Deaf excused the absence of Commissioners Garcia from the meeting on June 11, 2025, regular meeting.

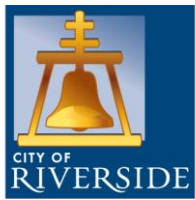
