### ATTENDANCE

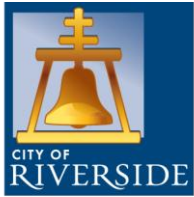
The Commission of the Deaf determined the absence of Commissioner Friend from the September 13, 2023 regular meeting as excused.
