

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 21052 AND THE MASTER FRINGE BENEFITS AND SALARY PLAN TO REFLECT THE 2026 STATE MANDATED INCREASE TO THE MINIMUM WAGE AND SALARY ADJUSTMENTS TO ADDITIONAL TEMPORARY JOB CLASSIFICATIONS TO MAINTAIN MINIMUM WAGE INCREASE DIFFERENTIALS.

WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council thereby adopting the Master Fringe Benefits and Salary Plan ("FBSP"); and

WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees; and

WHEREAS, the FBSP has been amended several times to update the benefits and salaries; and

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the 2026 State mandated increase to the minimum wage; and

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the salary adjustments to additional temporary job classifications to maintain minimum wage increase differentials.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as follows:

Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are hereby amended to 1) reflect the 2026 State mandated increase to the minimum wage; and 2) approve the salary adjustments to additional temporary job classifications to maintain minimum wage increase differentials, all as set forth in Exhibit "A" and Exhibit "B" attached hereto and incorporated herein by reference.

<u>Section 2</u>: Authorize the City Manager, or his designee, to make minor, nonsubstantive changes to the Master Fringe Benefits and Salary Plan and any related policies, procedures or documents necessary to implement these provisions.
