

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AUTHORIZING THE SUBMISSION OF AN
4 APPLICATION, AND ACCEPTANCE OF, GRANT FUNDS FROM THE
5 STATE OF CALIFORNIA - CALIFORNIA ARTS COUNCIL, FOR THE
6 IMPLEMENTATION BY THE RIVERSIDE ARTS ACADEMY TO
7 SUPPORT ARTS EDUCATION, MUSICAL INSTRUMENTS, EQUIPMENT
8 AND FACILITIES PROJECTS.

9 WHEREAS, the Governor of the State of California, in cooperation with the California State
10 Legislature, has approved a grant for a project to be administered by the Riverside Arts Academy to
11 fund Arts Education, Musical Instruments, Equipment and Facilities; and

12 WHEREAS, the California Arts Council has been delegated the responsibility for the
13 administration of the grant project, setting up necessary procedures governing application by local
14 agencies, non-profit organizations, and others under the program; and

15 WHEREAS, said procedures established by the California Arts Council require the applicant
16 to certify by resolution the approval of application before submission of said application to the State;
17 and

18 WHEREAS, the applicant will enter into a Grant Agreement with the State of California for
19 the grant project to fund Arts Education, Musical Instruments, Equipment and Facilities administered
20 through the Riverside Arts Academy.

21 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
22 California, as follows:

23 Section 1: Approves the filing of an application for grant funds with the State of California,
24 California Arts Council, for the grant project to fund Arts Education, Musical Instruments, Equipment
25 and Facilities administered through the Riverside Arts Academy in an amount not to exceed Five
26 Hundred Thousand Dollars (\$500,000.00).

27 Section 2: Agrees to, and if awarded, does accept the grant funds in an amount not to exceed
28 Five Hundred Thousand Dollars (\$500,000.00).

Section 3: Certifies that the City has or will have sufficient funds to operate and maintain the
project or will enter into an agreement with Riverside Arts Academy to perform said project.

1 Section 4: Certifies that the City has reviewed, understands, and agrees to the General
2 Provisions contained in the Grant Agreement shown in the Procedural Guide.

3 Section 5: Delegates the authority to the City Manager, or his designee, to conduct all
4 negotiations, sign and submit all documents including, but not limited to applications, agreements,
5 amendments, and payment requests, which may be necessary for the completion of the project.

6 Section 6: Agrees to comply with all applicable federal, state and local laws, ordinances, rules,
7 regulations and guidelines.
