ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, LEVYING SPECIAL TAXES TO BE COLLECTED DURING FISCAL 2024-2025 YEAR WITHIN **IMPROVEMENT** AREA NO. DISTRICT NO. 2006-1 COMMUNITY FACILITIES (RIVERWALK VISTA) OF THE CITY OF RIVERSIDE, CALIFORNIA, **DECLARING** THIS ORDINANCE TO BE **EFFECTIVE** ADOPTION.

The City Council of the City of Riverside does ordain as follows:

Section 1: Findings. The City Council finds as follows: (a) pursuant to the Amended and Restated Rates and Method of Apportionment of Special Tax for Improvement Area No. 1 of Community Facilities District No. 2006-1 (Riverwalk Vista) of the City of Riverside ("Improvement Area No. 1"), the City Council is authorized to levy Special Taxes in any Fiscal Year for the following purposes (i) to pay debt service on all outstanding Bonds (taking into consideration the amount of funds that may be available pursuant to the Indenture to pay such debt service); (ii) to pay periodic costs for the Bonds, including, but not limited to, costs related to credit enhancement and rebate payments; (iii) to pay Administrative Expenses; (iv) to provide an amount equal to reasonably anticipated delinquencies in the collection of Special Taxes; (v) to provide any amount required to replenish the reserve fund for the outstanding Bonds; and (vi) to provide any amounts that the City Council determines are necessary to pay the costs on the provision, construction and acquisition of public facilities and/or to accumulate funds therefor; (b) it is necessary that the City Council levy special taxes during Fiscal Year 2024-2025 on all Assessor's Parcels of Developed Property in Improvement Area No. 1 for the purposes of paying the costs of providing, constructing and acquiring public facilities and accumulating funds therefor, and paying Administrative Expenses; and (c) the words set forth above and hereinafter with initial letters capitalized are defined terms in the aforementioned Amended and Restated Rates and Method of Apportionment of Special Tax.

Section 2: Levy of Special Taxes. Special Taxes shall be and hereby are levied for Fiscal Year 2024-2025 on all parcels of Developed Property within Improvement Area No. 1, which are identified in Exhibit "A" attached hereto, and in the amount set forth for each such

1	Assessor's Parcel in said Exhibit "A." Pursuant to said Section 53340 of the California						
2	Government Code, such Special Taxes for Fund 68-2726 shall be collected in the same manner						
3	as ordinary ad valorem property taxes are collected and shall be subject to the same penalties and						
4	the same procedure, sale, and lien priority in case of delinquency as is provided for ad valorem						
5	taxes.						
6	Section 3: Transmittal to County. The City Clerk shall upon adoption of this ordinance						
7	cause a copy to be transmitted to the County Auditor of the County of Riverside together with a						
8	request that the special taxes as levied hereby be collected on the tax bills for the parcel						
9	identified in Exhibit "A" hereto, along with the ordinary ad valorem property taxes to be levied						
10	on and collected from the owners of said parcels.						
11	Section 4: Publication and Effective Date. The City Clerk shall certify to the adoption of						
12	this ordinance and cause publication once in a newspaper of general circulation in accordance						
13	with Section 414 of the Charter of the City of Riverside. This is an ordinance fixing the rate of						
14	taxation upon property and shall take effect immediately upon its adoption, pursuant to Section						
15	416 of the Charter of the City of Riverside.
