AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING CHAPTER 5.36 TO THE RIVERSIDE MUNICIPAL CODE REGARDING THE REGULATION OF MOBILE FOOD VENDORS.

The City Council of the City of Riverside does ordain as follows:

Section 1. Section 5.36.070 of the Riverside Municipal Code is hereby amended as follows:

## "Section 5.36.070 Sales from vending vehicles.

A. No mobile food merchant shall sell, display, solicit, barter, gift, or exchange or otherwise, any foodstuff or other item, from a vending vehicle within the corporate limits of the City of Riverside, except as set forth in this Code.

N. Ice cream vending. Mobile food merchants engaged in vending ice cream and similar food items in residential neighborhoods shall comply with California Vehicle Code Section 22456, as may be amended from time to time.

O. Mobile food vending vehicles shall be restricted from parking within fifty (50) feet of any commercial, industrial or residential driveway."

Section 2. The City Council has reviewed the matter and, by based upon the facts and information contained in the staff reports, administrative record, and written and oral testimony, hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change.

Section 3. The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
