

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, EXTENDING THE TERM OF THE AMERICAN MEDICAL  
4 RESPONSE SERVICES, INC. FRANCHISE TO OPERATE AUTHORIZED  
5 AMBULANCE VEHICLES TO NOVEMBER 8, 2024.

6 WHEREAS, the City Council by Ordinance No. 7440 granted a franchise to American  
7 Medical Response Ambulance Service, Inc. (“AMR”), which ordinance contains in Section 2,  
8 “TERM” a provision which authorizes the extension of the term of the franchise by resolution  
9 within the limits established by the Charter of the City of Riverside; and

10 WHEREAS, the term was originally established for five years; and

11 WHEREAS, the term also provided that “the term of this franchise may be further  
12 extended by Resolution of the City Council of the City”; and

13 WHEREAS, the City Council actions regarding AMR’s Franchise are documented in  
14 Council approval of Resolutions Nos. 20450, 20754, 20829, 21051, 21107, 21370, 22040,  
15 22097, 22411, and 22870; and

16 WHEREAS, Resolution No. 22870 extended the Franchise to June 18, 2018; and

17 WHEREAS, the City of Riverside and AMR desire to extend the Franchise to November  
18 8, 2024; and

19 WHEREAS, the rates set forth in this Resolution are consistent with the rate structure set  
20 forth and entered into pursuant to the terms of the Agreement with AMR for ALS First  
21 Responder and Ambulance Services dated November 8, 2018.

22 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
23 that the term of the Franchise established by Ordinance No. 7440 with American Medical  
24 Response Service, Inc. for ambulance services in the City of Riverside be extended from June  
25 30, 2023, to November 8, 2024.

26 FURTHERMORE, BE IT RESOLVED by the City Council of the City of Riverside that  
27 the current rates shall remain unchanged.
