## **BACKGROUND**

1. The Energy Efficiency and Conservation Block Grant (EECBG) program is a grant program funded by the Department of Energy (DOE).
2. The grant is designed to assist states, local governments, and Tribes to implement strategies to reduce energy use, reduce fossil fuel emissions, and improve energy efficiency.
3. The City received awarded funds to develop a comprehensive energy plan.
4. The City Council approved and accepted the awarded \$325,070 on November 19, 2024 – must be spent by October 1, 2026.

- 1. **High level baseline energy use** from electricity, natural gas, and transportation fuels (gasoline and diesel)
- 2. **Greenhouse gas emissions** from each energy sector
  - a. In coordination with the City's Climate Action and Adaptation Plan
  - b. Energy scenarios based on various levels of technology and policy adoption
- 3. **Needs assessment** for the electric utility and community
- 4. **Recommended actions and programs**
- 5. **Next steps proposal** for Board and City Council
