

EVERGREEN POWER OF ATTORNEY

By this Power of Attorney, City of Riverside, a company duly organized and existing under the laws of the State of California (the "Company"), hereby appoints Jeffrey K. Simpson, Andrew Rennick, and Brian W. Thomas of Womble Bond Dickinson (US) LLP ("Womble Bond") and such other representatives of Womble Bond designated by either of them, jointly and severally, as true and lawful attorneys-in-fact and agents of the Company and authorizes such attorneys-in-fact and their agents to, in the name, place, and stead of the Company,

- (1) make, sign, and enter into an insurance agreement, Policy No.P25-032, and any renewal thereof (including any new policy number for the same insurance agreement, even if not expressly provided herein), together with any amendments and endorsements thereof, including endorsements that effect a policy number change (collectively, the "Insurance Agreement"), by and between the Company and Nuclear Electric Insurance Limited, a Bermuda mutual company with limited liability ("NEIL"), providing for, among other things, payment by the Company of insurance premiums and retrospective premium adjustments, all as set forth in the Insurance Agreement;
- (2) make, sign, and enter into the Waiver of Rights Agreement and any Joinders thereto (the "Waiver", and together with the Insurance Agreements, the "Agreements") by and among the Company and other insureds of NEIL for the benefit of NEIL, pursuant to which, among other things, the Company waives certain statutory rights that might otherwise be available to it;
- (3) make, sign, and enter into any and all certificates, agreements, instruments, and other documents and to take any and all steps which any of them reasonably deems necessary or advisable in order to carry out the foregoing transactions;
- (4) make, sign, and enter into any amendments to the Waiver, as instructed by authorized employees or agents of the Company, until the expiration of the Agreements; and
- (5) act as the Company's representative in Delaware with respect to the Insurance Agreements and the insurance coverage or coverages contemplated thereunder, with full authority to accept on behalf of the Company any communication or payment from NEIL and to send any communication or payment to NEIL, as instructed by authorized employees or agents of the Company, including accepting delivery of, and retaining, the Agreements and other related documents on a secure website owned and maintained by Womble Bond;

all as fully as the Company could do if present in Delaware and acting on its own behalf. The Company hereby ratifies all acts of said attorneys-in-fact and their agents that are taken lawfully and in accordance with this Power of Attorney. This Power of Attorney will remain in full force and effect until revoked in a writing duly delivered to (i) NEIL at its address at 1 Righter Parkway, Suite 210, Wilmington, DE 19803, U.S.A., or such other address or email address(es) as NEIL may later provide, and (ii) Womble Bond at its address at 1313 North Market Street, Suite 1200, Wilmington, DE 19801, U.S.A., or such other address or email address(es) as Womble Bond may later provide.
