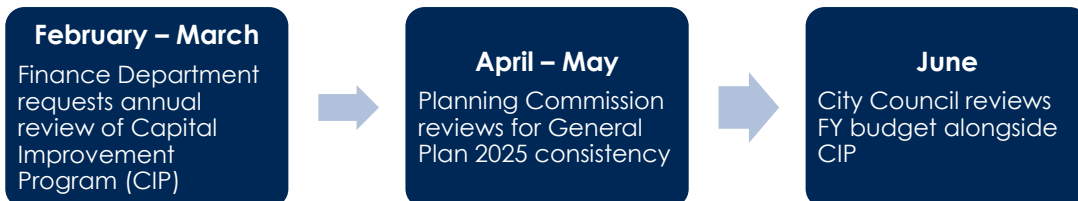

GENERAL PLAN CONSISTENCY

- **April 28, 2022:** Planning Commission reviewed 45 projects and determined General Plan 2025 consistency of the FY 2022/2024 CIP
- **Current Review:** FY 2023/2024 CIP
 - 22 new projects previously not considered
 - Anticipated to be considered by City Council in June 2023

That the Planning Commission:

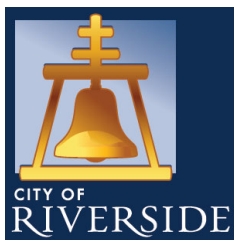
- **DETERMINE** that PR-2023-001501, review of the City of Riverside's capital improvement projects for FY 2023/24, is not subject to the California Environmental Quality Act (CEQA) review, pursuant to CEQA Guidelines Section 15061(b)(3) as this action is not considered a "project" as defined by Section 15378(b)(4), and a determination of consistency has no potential to result in a direct or indirect physical change in the environment;
- **FIND** that the capital improvement projects added for FY 2023/24 are consistent with the City's General Plan 2025; and
- **REPORT** to the City Council that the capital improvement projects added for FY 2023/24 are consistent with the City's General Plan 2025.
