## TERMINATION OF AGREEMENT

This TERMINATION OF AGREEMENT ("Termination Agreement") is entered into as of this day of, 2025 ("Effective Date") by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City") and the COUNTY OF RIVERSIDE, a political subdivision of the State of California, on behalf of its Department of Animal Services ("County").	
RECITALS	
WHEREAS, on July 1, 2007, the City and County entered into an Agreement for Animal Shelter Services (the "2007 Agreement"), wherein the County agreed to provide animal shelter services during the period of July 1, 2007 through June 30, 2012; and	
WHEREAS, on April 22, 2010, the City and County entered into a First Amendment to Agreement for Animal Shelter Services ("First Amendment") to revise the scope, compensation, and to extend the term to 2035 and other terms; and	
WHEREAS, on December 14, 2010, the City and County entered into a Second Amendment to Agreement for Animal Shelter Services ("Second Amendment") to revise the Scope of Services; and	
WHEREAS, on October 22, 2012, the City and County entered into a Third Amendment to Agreement for Animal Shelter Services ("Third Amendment") to revise the Scope of Services, fees, charges, and other revenues; and	
WHEREAS, on, the City and County have entered into an Agreement for Animal Field and Shelter Services Between the City of Riverside and the County of Riverside that renders 2007 Agreement unnecessary.	
WHEREAS, the City and County mutually desire to terminate the 2007 Agreement and all amendments thereto.	
TERMS	
In consideration of valuable consideration and of mutual agreements herein contained, the parties hereby agree as follows:	
1. The parties hereby mutually agree that the Agreement for Animal Shelter Services dated July 1, 2007 and the First Amendment, Second Amendment, and Third Amendment (the "Amendments") thereto are terminated effective, 2025 ("Termination Date").	
2. The parties hereby mutually agree that the County shall cease to provide Animal Shelter Services to the City under the terms of the 2007 Agreement and all of the Amendments thereto upon the execution of this Termination Agreement ("Termination Date").	

3. The parties hereby mutually agree that County shall be compensated for services rendered through the Termination Date as provided in the 2007 Agreement and the Amendments thereto. County shall submit final invoice to the City no later than 30 days after the Termination Date, which shall be paid in accordance with the 2007 Agreement and the Amendments thereto as per the City's usual accounting procedures.
