

SECOND AMENDMENT TO

THIS SECOND AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("Second Amendment") is made and entered into this _____ day of _____, _____, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and GEOLOGIC ASSOCIATES, INC., a California corporation ("Consultant"), with respect to the following:

RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated November 4, 2021 ("Agreement"), for Water Monitoring and Reporting Services for the Inactive Tequesquite Landfill, Riverside, California (RFP No. 2098); and

WHEREAS, the City and Consultant entered into that certain First Amendment to Professional Consultant Services Agreement dated July 1, 2024 ("First Amendment"), to extend the Term of the Agreement, add additional Compensation, and add additional Key Personnel; and

WHEREAS, the Agreement is set to expire on June 30, 2025; and

WHEREAS, paragraph 2 of the Agreement states that upon mutual agreement of the parties, the term of the Agreement may be extended for up to two (2) additional one (1)-year terms, not to exceed two (2) years based upon the acceptable performance of the Consultant, acceptable fees and subject to the same terms and conditions of the Agreement; and

WHEREAS, the City and Consultant desire to extend the term of the Agreement by one (1) additional year, through June 30, 2026; and

WHEREAS, the City and the Consultant desire to amend the Scope of Services by adding additional services; and

WHEREAS, the City and Consultant desire to add additional Compensation in the amount of Ninety-Three Thousand One Hundred Twenty-Three Dollars (\$93,123.00) for the extended Term of the Agreement.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

1. Section 2, Term, is hereby amended to extend the term of the Agreement by one (1) additional year, through June 30, 2026.

2. Exhibit "A" of the Agreement, Scope of Services, is amended to add Exhibit "A-2," attached hereto and incorporated herein by this reference.

3. Section 3, Compensation/Payment, is hereby amended to increase the Compensation in the amount of Ninety-Three Thousand One Hundred Twenty-Three Dollars (\$93,123.00) for the extended Term of the Agreement for a total Agreement sum not to exceed Three Hundred Two Thousand Three Hundred Sixty-Two Dollars (\$302,362.00). Exhibit "B" of the Agreement is amended to add Exhibit "B-2," attached hereto and incorporated herein by this reference.

4. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Second Amendment, shall remain in full force and effect as if fully set forth herein.
