

**FIRST AMENDMENT TO
PROFESSIONAL CONSULTANT SERVICES AGREEMENT**

THIS FIRST AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT (“First Amendment”) is made and entered into this _____ day of _____, 2023, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), RICHARD HEATH & ASSOCIATES, INC. a California corporation (“Consultant”), with respect to the following facts:

RECITALS

WHEREAS, on January 23, 2023, City and Richard Heath & Associates, Inc., entered into that certain Professional Consultant Services Agreement, in conjunction with Consultant Administered Direct Installation Services for Small Business – RFP No. 2139 (“Agreement”), in the amount of One Million Two Hundred Fifty Dollars (\$1,250,000); and

WHEREAS, the City and Consultant desire to amend the Agreement to increase compensation not to exceed Three Million Seven Hundred Fifty Dollars (\$3,750,000.00); and

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Consultant agree as follows:

1. Section 3, Compensation/Payment, is amended to increase the compensation to an amount not to exceed One Million Two Hundred Fifty Thousand Dollars (\$1,250,000) annually for a contract total not to exceed Three Million Seven Hundred Fifty Thousand Dollars (\$3,750,000). Compensation for the optional extensions shall be an amount not to exceed One Millions Two Hundred Fifty Thousand Dollars (\$1,250,000) per year.

2. All other terms and conditions of the Agreement between the parties which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.
