A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH TIMED 30-MINUTE PARKING ON MAIN STREET.

WHEREAS, the Public Works Department received a request from 86% of area businesses near 2879 / 2891 Main Street to establish a timed 30-Minute Parking zone on the west side of Main Street from 585 feet south of Poplar Street (just south of the driveway of 2879 Main Street) to 150 feet southerly thereof; and

WHEREAS, the establishment of the zone will encourage more frequent turnover of available on-street parking by creating needed short-term parking during peak business days and times to better serve area business patrons; and

WHEREAS, on October 1, 2025, the Transportation Board unanimously approved staff's recommendation to establish a "30-Minute Parking between the hours of 7:00 a.m. to 6:00 p.m. Monday through Friday" zone on the west side of Main Street from 585 feet south of Poplar Street to 150 feet southerly thereof.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

<u>Section 1</u>: The recitals set forth above are incorporated herein by reference.

Section 2: That the Master Parking Schedule is hereby amended by establishing the "30-Minute Parking between the hours of 7:00 a.m. to 6:00 p.m. Monday through Friday" zone on the west side of Main Street from 585 feet south of Poplar Street to 150 feet southerly thereof.

<u>Section 3</u>: That the provisions of this resolution shall be operative only when signs are erected on that portion of the street set forth in Section 2 above, giving notice of the parking limitations or prohibitions herein established.

<u>Section 4</u>: The provisions of this amendment shall be operative as of the date of adoption of this resolution.
