### **BACKGROUND**

- 1. The California Water Code Section 10632.1 requires an Annual Assessment and Annual Shortage Report to the California Department of Water Resources (DWR) by July 1 of each year since 2022.
- 2. The assessment and report are based on the procedures and recommendations provided by the DWR.
- 3. Final guidance documents were published in April 2022, followed by the publication of a Guidance addendum on May 10, 2023.

#### **BACKGROUND**

The purpose of the Annual Assessment is to:

- 1. Evaluate Water Agencies on their water supply reliability for the current year and including one dry year.
- 2. Generate and submit an Annual Shortage Report on the Annual Assessment and results every year regarding their anticipated shortages to DWR by July 1.

#### **DISCUSSION**


#### Riverside's Available Water Supply Projection in 2024-2025:

- 1. The Annual Assessment reflects the available water supply from groundwater extraction rights, as shown on the next slide.
- 2. Considers the available capacity from groundwater supply wells during high demand and conveyance capability.
- 3. An agreement with Western Municipal Water District (WMWD) provides access to 21,700 acre feet per year (AFY) of imported water.
- 4. Recycled water for non-potable uses meets the need of up to 800 AFY

- 2. Considering the monthly projected weather and growth.






