

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, APPROVING THE CITY OF  
4 RIVERSIDE EMERGENCY OPERATIONS PLAN 2025; AND  
5 REPEALING RESOLUTION NO. 22151.

6 WHEREAS, the City of Riverside (“City”) promotes and supports the goal of a prepared  
7 disaster-resilient community; and

8 WHEREAS, the preservation of life, property and the environment is an inherent  
9 responsibility of local, state and Federal governments; and

10 WHEREAS, the California Emergency Act requires cities to have an Emergency Operations  
11 Plan to ensure effective operations in the event of emergency or disaster; and

12 WHEREAS, Chapter 9.20 of the Riverside Municipal Code requires the development and  
13 submission of an emergency operations plan to the City Council for adoption; and

14 WHEREAS, the Emergency Operations Plan establishes the emergency organization,  
15 concept of operations, and processes for coordination of the City’s responsibilities as a member of  
16 the Riverside Operations Area along with other Operations Area organizations; and

17 WHEREAS, the City wishes to provide for the organization of emergency services and  
18 coordination of emergency functions within the City and with other public agencies, private  
19 organizations, and businesses; and

20 WHEREAS, the City has developed an Emergency Operations Plan that is Standardized  
21 Emergency Management System (SEMS) and National Incident Management System (NIMS)  
22 compliant; and

23 WHEREAS, the City previously adopted its Emergency Operations Plan with the adoption of  
24 Resolution No. 22151; and

25 WHEREAS, the approval of the revised and updated Emergency Operations Plan is  
26 necessary to ensure disaster and emergency preparedness.

27 NOW, THEREFORE, the City Council does hereby resolve, determine and order as follows:

28 Section 1. That the Emergency Operations Plan dated 2025, attached hereto as Exhibit “A”  
and incorporated herein by this reference, is approved as the Emergency Operations Plan for the City  
of Riverside.
