SUBJECT: AWARD BID NO. 8201 FOR THE CONSTRUCTION OF HOUGHTON AVENUE STORM DRAIN IMPROVEMENTS GHC PIPELINE, LLC., OF RIVERSIDE, CALIFORNIA IN THE AMOUNT OF \$248,489

ISSUE:

Award Bid No. 8201 for the construction of Houghton Avenue Storm Drain Improvements to GHC Pipeline, LLC., of Riverside, California, in the amount of \$248,489.

RECOMMENDATIONS:

That the City Council:

1. Award Bid No. 8201 for the construction of Houghton Avenue Storm Drain Improvements to GHC Pipeline, LLC., of Riverside, California, in the amount of \$248,489; and
2. Authorize the City Manager, or his designee, to execute the construction contract with GHC Pipeline, LLC., including making minor non-substantial changes.

BACKGROUND:

The project site is located on Houghton Avenue near Fairmount Park (Attachment 1). During heavy rain events, Houghton Avenue floods into private properties due to inadequate drainage. The installation of the new storm drain line under Houghton Avenue will alleviate the flooding concerns.

DISCUSSION:

On August 14, 2025, Bid No. 8201 for the Houghton Avenue Storm Drain Improvements was posted on PlanetBids. The proposed project includes the installation of approximately 400 linear feet of underground storm drain pipes and ancillary structures within the public right-of-way along Houghton Avenue and Pine Street. Prior to bid opening, there were eight (8) questions received and answered, and no addenda were issued. The RFB notification is summarized in the following table:

On September 18, 2025, a total of seventeen (17) bids were received for the construction of the Project (see Attachment 2). One company, Prestige Prime Engineering, withdrew their bid due to a clerical error in the pricing. Another company, Demo Leaders, Inc. withdrew their bid due to their current circumstances and organizational capacity. A summary of the bid results is provided in the table below:

The lowest responsive and responsible bid was received from GHC Pipeline, LLC., in the amount of \$248,489, which is 18.28% over the Engineer's Estimate.

Purchasing Resolution 24101, Article Five, Section 508 states, "Contracts procured through Formal Procurement shall be awarded by the Awarding Entity to the Lowest Responsive and Responsible Bidder."

The Purchasing Manager concurs that the recommended actions comply with Purchasing Resolution 24101.

FISCAL IMPACT:

The fiscal impact of the construction contract is \$248,489. The estimated total project cost including design, construction, construction engineering, and contingencies is \$315,000 as

detailed in Table 3 – Project costs. Sufficient funds are budgeted and available in the Gas Tax Fund, Houghton Ave Storm Drain Improvement project account number 9932727-440223 to award the contract and complete the project.
