A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 21052 AND THE MASTER FRINGE BENEFITS AND SALARY **APPROVE CREATION PLAN** TO THE OF THE CLASSIFICATION AND SALARY RANGE FOR THE RECORDS MANAGER; SALARY ADJUSTMENT TO THE EXISTING SUPERVISOR, **UTILITIES** RECREATION **ELECTRIC UTILITIES** SUPERINTENDENT, DISPATCH SUPERINTENDENT, UTILITIES ELECTRIC FIELD MANAGER, UTILITIES ELECTRIC OPERATIONS MANAGER, UTILITIES **WASTEWATER GENERATION** PLANT MANAGER, AND **OPERATIONS** MANAGER CLASSIFICATIONS: **CHANGES** TO THE **EXISTING** CHIEF FINANCIAL OFFICER/CITY TREASURER, ASSISTANT CHIEF FINANCIAL OFFICER CLASSIFICATIONS; REINSTATEMENT ASSISTANT CITY MANAGER/CFO CLASSIFICATION AND SALARY RANGE; BARGAINING UNIT REASSIGNMENT FOR THE ORGANIZATIONAL DEVELOPMENT AND TRAINING MANAGER CLASSIFICATION; AND DELETION OF NON-UTILIZED UTILITIES DISPATCH SUPERINTENDENT JOB CLASSIFICATION.

WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council thereby adopting the Master Fringe Benefits and Salary Plan ("FBSP"); and

WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees; and

WHEREAS, the FBSP has been amended several times to update the benefits and salaries; and

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the creation of the new classification and salary range for the Records Manager; and

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the salary adjustments to the existing Recreation Supervisor, Utilities Electric Superintendent, Utilities Dispatch Superintendent, Utilities Electric Field Manager, Utilities Electric Operations Manager, Utilities Generation Plant Manager, and Wastewater Operations Manager classifications; and

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the title changes to the existing Chief Financial Officer/City Treasurer and the Assistant Chief Financial Officer classifications; and

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the reinstatement of the Assistant City Manager/CFO classification and salary range; and

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the bargaining unit reassignment for the Organizational Development and Training Manager classification; and

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the deletion of non-utilized Utilities Dispatch Superintendent job classification.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as follows:

Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are hereby amended to 1) approve the creation of the new classification and salary range for the Records Manager; 2) approve the salary adjustments to the existing Recreation Supervisor, Utilities Electric Superintendent, Utilities Dispatch Superintendent, Utilities Electric Field Manager, Utilities Electric Operations Manager, Utilities Generation Plant Manager, and Wastewater Operations Manager classifications, 3) approve the title changes to the existing Chief Financial Officer/City Treasurer and the Assistant Chief Financial Officer classifications, 4) approve the reinstatement of the Assistant City Manager/CFO classification and salary range, 5) approve the bargaining unit reassignment for the Organizational Development and Training Manager classification, and 6) approve the deletion of the non-utilized Utilities Dispatch Superintendent job classification, all as set forth in Exhibit "A" attached hereto and incorporated herein by reference.

<u>Section 2</u>: Authorize the City Manager, or designee, to ma.ke minor, non-substantive changes to the Master Fringe Benefits and Salary Plan and any related policies, procedures or documents necessary to implement these provisions.

<u>Section 3:</u> The provisions of this resolution shall be operative upon adoption.
